Mr Daaboul was found guilty and fined \$50.</p>

Mr Maye was issued with a severe reprimand and asked to ensure that all greyhounds are correctly kenneled in future. This matter was referred to the Club Manager for further consideration.

Stewards conducted an inquiry into the circumstances surrounding the late scratching of the greyhound Bendis Bale after it was established that Mr J.Sayle, trainer had presented the incorrect greyhound for racing. Stewards charged Mr Sayle with a breach of 86(o). Mr Sayle pleaded guilty to the charge and was fined the sum of \$100.

Satisfactory Trial Results - Bookbinder trialled over the 460m, from box 5, weight 36.0kg, the greyhound was placed 1st in a field of four starters. The time of the trial was 26.13, the greyhound won by a margin of 4 lengths. Bookbinder was cleared.

Satisfactory Trial Results - Bazz Kebab trialled over the 460m, from box 2, weight 31.5kg, the greyhound was placed 2nd in a field of four starters. The time of the trial was 26.13, the greyhound was beaten by a margin of 4 lengths. Bazz Kebab was cleared.

Satisfactory Trial Results (Remove Blinkers) - Prancing Magic trialled over the 460m, from box 8, weight 30.8kg, the greyhound was placed 3rd in a field of four starters. The time of the trial was 26.13, the greyhound was beaten by a margin of 4.25 lengths. Prancing Magic was cleared to race without blinkers.
