The time of the trial was 26.06, the greyhound won by a margin of 3.75 lengths. Ultimate Return was cleared.</p> <p>Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mr Clint Arthur, the trainer of Magic Buddie</p>

regarding the length of time since the greyhound last raced. Magic Buddie last raced on 5th February 2016. Mr Arthur stated that the greyhound was returning to racing after a left shoulder injury.
