Topaz Warrior was found guilty and stewards directed that the greyhound perform a Satisfactory Trial (all tracks) pursuant to GAR 69 (B)(1)(a), before any future nomination will be accepted.</p>

Meeting Comments

Satisfactory Trial Results

Quick Return trialled over the 390 metre distance from box 1, weight 31.3kgs. The greyhound was placed 3rd, in a field of 4. The time of the trial was 22.32. The greyhound was beaten by a margin of 5.5 lengths. Quick Return was cleared.

Stewards spoke to Ms. T. Salter, the trainer of Tears Some regarding the length of time since the greyhound last raced. Tears Some last raced on 22nd June 2016. Ms. Salter stated that the greyhound was returning to race after being on season.

Pursuant to GAR 77A, Tears Some trialled over the 390 metre distance from box 2, weight 28.1kgs. The greyhound was placed 1st, in a field of 4. The time of the trial was 22.32. The greyhound won by a margin of 5.25 lengths. Tears Some was cleared.
