It was reported that the greyhound sustained injuries to the right quadriceps, a five day stand down period was imposed. Acting under GAR 69(B)(1), the stewards charged Destini Baby with failing to pursue the lure with due commitment (by reason of injury). Mr. Taylor pleaded guilty to the charge, Destini Baby was found guilty and stewards directed that the greyhound perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1)(a), before any future nomination will be accepted.

Stevie O'Muffin was vetted following the event. It was reported that the greyhound sustained injuries to the right monkey muscle and right wrist, a ten day stand down period was imposed.
