#### Race 1

Mr. Haley was reminded of his responsibilities and asked to ensure that all greyhounds are correctly kennelled in future. This matter was referred to the Club Manager for further consideration.

Acting under GAR 69(B)(1), the stewards charged Djays Larry with failing to pursue the lure with due commitment (by reason of injury). Mr. Daisley pleaded not guilty to the charge. Djays Larry was found guilty and stewards directed that the greyhound must perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1)(a), before any future nomination will be accepted.

Stewards spoke to Mr R. Tartaglia, the trainer of Thundering Star regarding the length of time since the greyhound last raced. Thundering Star last raced on 15 June 2015.
