Tommy Two and Tweedle Dumb were slow to begin. Tommy Two galloped on the heels of Splash Of Blue soon after the start, checking Splash Of Blue. Satisfactory Trial Results (GAR 77A) - Stewards spoke to Ms. A. Terry, the representative of Amlin Boy regarding the length of time since the greyhound last raced. Amlin Boy last raced on 13th May 2016. Ms. Terry stated that the greyhound was recovering from an injury to the left stopper. Pursuant to GAR 77A, Amlin Boy trialled over the 300m from box one, weight 32.6kg, the greyhound was placed second in a field of six. The time of the trial was 16.79, the greyhound was beaten by a margin of 1.25 lengths. Amlin Boy was Cleared.

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mr. B. Seymour, the trainer of Miss Belladonna regarding the length of time since the greyhound last raced. Miss Belladonna last raced on 17th July 2016. Mr. Seymour stated that the greyhound was recovering from an injury to the right shoulder and had been on season. Pursuant to GAR 77A, Miss Belladonna trialled over the 300m from box two, weight 28kg, the greyhound was placed first in a field of six. The time of the trial was 16.79, the greyhound won by a margin of 1.25 lengths. Miss Belladonna was Cleared.

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mr. W. Alley, the trainer of Cee Cee Senor regarding the length of time since the greyhound last raced. Cee Cee Senor last raced on 16th May 2016. Mr. Alley stated that the greyhound was recovering from an injury to the left hock. Pursuant to GAR 77A, Cee Cee Senor trialled over the 300m from box three, weight 33.3kg, the greyhound was placed third in a field of six. The time of the trial was 16.79, the greyhound was beaten by a margin of 1.5 lengths. Cee Cee Senor was Cleared.

Mr. W. Alley, representative of Cee Cee Senor declared a new weight of 33.3kg for the greyhound in accordance with GAR 39(2). Cee Cee Senor last raced at 31.8kg.

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mr. B Seymour, the trainer of Ruby Sparks regarding the length of time since the greyhound last raced. Ruby Sparks last raced on 22nd November 2015. Mr. Seymour stated that the greyhound was recovering from a right back muscle injury and right triangle injury, and had been on season. Pursuant to GAR 77A, Ruby Sparks trialled over the 300m from box five, weight 29.3kg, the greyhound was placed fifth in a field of six. The time of the trial was 16.79, the greyhound was beaten by a margin of 6.75 lengths. Ruby Sparks was Cleared.

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mr. M. Ryan, the trainer of Race Roquette regarding the length of time since the greyhound last raced. Race Roquette last raced on 22nd May 2016. Mr. Ryan stated that the greyhound was having a spell. Pursuant to GAR 77A, Race Roquette trialled over the 300m from box seven, weight 33.9kg, the greyhound was placed fourth in a field of six. The time of the trial was 16.79, the greyhound was beaten by a margin of 4.75 lengths. Race Roquette was Cleared.
