Satisfactory Trial Results

Stewards spoke to Ms. K. Collyer, the trainer of West On Xandi regarding the length of time since the greyhound last raced. West On Xandi last raced on 29th June 2016. Ms. Collyer stated that the greyhound was returning to race after a right wrist injury. Pursuant to GAR 77A, West On Xandi trialled over the 390 metre distance from box 1, weight 26.8kgs. The greyhound was placed 3rd, in a field of 4. The time of the trial was 22.78. The greyhound was beaten by a margin of 3.5 lengths. West On Xandi was cleared.

Stewards spoke to Mr. P. Abela, the representative of the greyhound Oakleigh Rose regarding the length of time since the greyhound last raced. Oakleigh Rose last raced on 22nd July 2016. Mr. Abela stated that the greyhound was returning to race after being on season. Pursuant to GAR 77A, Oakleigh Rose trialled over the 390 metre distance from box 3, weight 30.1kgs.
