#### Race 1

TAB.COM.AU (300+RANK)

Hey Shaza Fozz and Crainy's Wish collided approaching the winning post, checking both greyhounds.

Stewards spoke to Mr Thomas Sharp, the trainer of the greyhound Rocketness regarding the greyhound's racing manners in the home straight. Rocketnesswas vetted, and re-vetted following event ten. It was reported that the greyhound sustained a carpal sprain to the right wrist, a ten-day stand down period was imposed. Acting under GAR 69(B)(1), the stewards charged Rocketness with failing to pursue the lure with due commitment (by reason of injury). Mr Sharp pleaded guiltyto the charge, Rocketness was found guilty and stewards directed that the greyhound perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1) (a), before any future nomination will be accepted.

Oity Allen was vetted following the event. It was reported that the greyhound sustained no apparent injury. No stand down period was imposed.

Stewards spoke to Ms Heather Collins, the trainer of the greyhound Oity Allen, regarding the greyhound's racing manners approaching the winning post. Acting under GAR 69(1), stewards charged Oity Allen with marring. Ms Collins pleaded guilty to the charge, Oity Allen was found guilty and suspended for 28 days at Geelong and it was directed that the greyhound perform a Satisfactory Trial (all tracks), pursuant to GAR 69(2)(a) before any future nomination will be accepted.
