Race 1

Lakeview Maisey was found guilty and stewards directed that the greyhound perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1)(a), before any future nomination will be accepted.

Satisfactory Trial Results - Clyde's Classy trialled over the 440m from box 1, weight 34.9kgs, the greyhound was placed 2nd in a field of 4. The time of the trial was 25.57, the greyhound was beaten by a margin of 1.75 lengths. Clyde's Classy was Cleared.

Satisfactory Whelping Trial - Stewards spoke to Mrs. D. Johnston the trainer of Zelemar Rose regarding the length of time since the greyhound last raced. Zelemar Rose last raced on 27th February 2016. Mrs Johnston stated that the greyhound was returning to racing following whelping and spell.
