Mr Bravo stated the greyhound was recovering from a right hock injury. Pursuant to GAR77A Time No Money trialled over the 450m from box 8, weight 28.5kgs, the greyhound was placed 1 in a field of 4. The time of the trial was 25.41, the greyhound won by a margin of 6 lengths. Time No Money was Cleared.
