Satisfactory Trial Results (GAR 77A) - Stewards spoke to Ms. C. O'Brien, the trainer of Hello Sunshine regarding the length of time since the greyhound last raced. Hello Sunshine last raced on 22nd July, 2015. Ms O'Brien stated that the greyhound had whelped a litter. Pursuant to GAR 77A, Hello Sunshine trialled over the 300m from box 2, weight 31.3kg, the greyhound was placed 1st in a field of 4. The time of the trial was 17.23, the greyhound was beaten by a margin of 1 length. Hello Sunshine was Cleared. Straight track only.
