Acting under GAR 69(B)1 the Stewards charged Cosmic Witch with failing to pursue the lure with due commitment by reason of injury. Mr. Hall pleaded not guilty to the charge. Cosmic Witch was found guilty and Stewards directed that the greyhound perform a satisfactory trial all tracks pursuant to GAR 69(B) (1)(a) before any future nomination will be accepted.
