Meteor Panther last raced at 31.2 kg's.</p> <p>Stewards spoke to Mr. F. Malloy, the trainer of Cosmic Object regarding the length of time the greyhound has had between races. Cosmic Object last raced on 19th of October, 2015. Mr. Malloy stated that Cosmic Object is returning to racing after sustaining an injury to it's left hock.</p> <p>Gypsy Wendy and Lucky Andy collided soon after the start.
