Meeting Comments

Satisfactory Trial

Dr. Nicholas trialled over the 315 metre distance from box 3, weight 32.1kgs. The greyhound was placed 2nd, in a field of 4. The time of the trial was 18.37. The greyhound was beaten by a margin of nose. Dr. Nicholas was cleared.

Stewards spoke to Mr. K. Bailey, the trainer of Select Shadow regarding the length of time the greyhound has had between races. Select Shadow last raced on 17th May 2015. Mr. Bailey stated that the greyhound was returning to racing after being on season. Pursuant to GAR 77A, Select Shadow trialled over the 315 metre distance from box 1, weight 30.3kgs. The greyhound was placed 3rd, in a field of 4. The time of the trial was 18.37. The greyhound was beaten by a margin of 10.5 lengths. Select Shadow was cleared.

Stewards spoke to Mr. K. Bailey, the trainer of Select Seaspray regarding the length of time the greyhound has had between races. Select Shadow last raced on 12th July 2015. Mr. Bailey stated that the greyhound was returning to racing after illness. Pursuant to GAR 77A, Select Seaspray trialled over the 315 metre distance from box 5, weight 34.8kgs. The greyhound was placed 1st, in a field of 4. The time of the trial was 18.37. The greyhound won by a margin of a nose. Select Seaspray was cleared.
