Race 1

BRENDAN DODD SIGNS (300+RANK)

Meeting Comments

Satisfactory Trial Results

390m

Stewards spoke to Ms. J. Rinaldi, the trainer of Destini Mirror regarding the length of time since the greyhound last raced. Destini Mirror last raced on 5th September 2016. Ms. Rinaldi stated that the greyhound was resuming racing after an injury to the right stopper bone. Pursuant to GAR 77A, Destini Mirror trialled over the 390 metre distance from box 1, weight 31.6kgs. The greyhound was placed 2nd, in a field of 4. The time of the trial was 23.14. The greyhound was beaten by a margin of 2.5 lengths. Destini Mirror was cleared.

Stewards spoke to Ms. J. Rinaldi, the trainer of Destini Teerex regarding the length of time since the greyhound last raced. Destini Teerex last raced on 7th August 2016. Ms. Rinaldi stated that the greyhound was resuming racing following an injury to its right metacarpals. Pursuant to GAR 77A, Destini Teerex trialled over the 390 metre distance from box 3, weight 37.3kgs. The greyhound was placed 1st, in a field of 4. The time of the trial was 23.14. The greyhound won by a margin of 2.5 lengths. Destini Teerex was cleared.

Stewards spoke to Ms. M. McGuire, the trainer of Pitil Grange regarding the length of time since the greyhound last raced. Pitil Grange participated in a coursing event at Lang Lang on 26th June 2016. Ms. McGuire stated that the greyhound was new to her kennels. Pursuant to GAR 77A, Pitil Grange trialled over the 390 metre distance from box 7, weight 27.1kgs. The greyhound was placed 3rd, in a field of 4. The time of the trial was 23.14. The greyhound was beaten by a margin of 6 lengths. Pitil Grange was cleared.
