Secret Chord checked off Searching on the first turn. Oddball Quick crossed to the rail approaching the home turn, severely checking Searching. Ledgerwood Molly and Verta Bale collided approaching the home turn, and again on the home turn, checking both greyhounds. Secret Chord galloped on the heels of Searching entering the home straight, checking both greyhounds. Trouble pulled up in the home straight and failed to finish.

Trouble was vetted following the event. It was reported that there was no apparent injury found. Trainer Mrs. L. Delbridge declined to have the greyhound re-vetted.

Searching was vetted following the event. It was reported that the greyhound sustained an injury to the right triangle, a 7 day stand down period was imposed.

A sample was taken from Oddball Quick - the winner of the event.

Stewards spoke to Mrs. L. Delbridge, the trainer of the greyhound Trouble regarding the greyhounds racing manners in the home straight. Acting under GAR 69(A)(1) stewards charged Trouble with failing to pursue the lure with due commitment. Mrs. Delbridge pleaded guilty to the charge, Trouble was found guilty and suspended for 28 days at Warrnambool and it was directed that the greyhound perform a Satisfactory Trial (all tracks), pursuant to GAR 69(A)(2)(a) before any future nomination will be accepted.

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Ms. P. Bryant, the trainer of Carry On Rose regarding the length of time since the greyhound last raced. Carry On Rose last raced on 6th May 2016. Ms. Primrose stated that the greyhound had been on season. Pursuant to GAR 77A, Carry On Rose trialled over the 390m from box one, weight 26.5kg, the greyhound was placed third in a field of four. The time of the trial was 22.53, the greyhound was beaten by a margin of 2.5 lengths. Carry On Rose was Cleared.
