Moreira Magic was vetted following the event and re-vetted 40 minutes later. It was reported that the greyhound was found to have soreness in both hind legs, a 5 day stand down period was imposed.

Stewards spoke to Mr. P. Pace the trainer of the greyhound Moreira Magic. Stewards deemed the performance of Moreira Magic unsatisfactory in this event and acting in accordance with GAR 71 Stewards directed that Moreira Magic must perform a satisfactory trial all tracks before any future nomination will be accepted.

Meeting comments:-

Satisfactory trial results:-

Amlin Boy trialled over 315 metres from box 1, weight 32.5kg, the greyhound was placed first, in a field of 4. The time of the trial was 17.93 secs, the greyhound won by a margin of 4.25 lengths. Amlin Boy was cleared.

Satisfactory trial results (GAR 77A):-

Stewards spoke to Mr. G. O'Keefe the trainer of Sudden Burst regarding the length of time since the greyhound last raced. Sudden Burst last raced on 07/09/16. Mr. O'Keefe stated that the greyhound was returning to racing following a change of kennel. Sudden Burst trialled over 315 metres from box 3, weight 31.0kg, the greyhound was placed third, in a field of 4. The time of the trial was 17.93 secs, the greyhound was beaten by a margin of 7 lengths. Sudden Burst was cleared.

Stewards spoke to Mr. S. Jack the trainer of Elram Girl regarding the length of time since the greyhound last raced. Elram Girl last raced on 13/07/16. Mr. Jack stated that the greyhound was returning to racing following a dislocated right knee. Elram Girl trialled over 315 metres from box 8, weight 27.0kg, the greyhound was placed second, in a field of 4. The time of the trial was 17.93 secs, the greyhound was beaten by a margin of 4.25 lengths. Elram Girl was cleared.
