Mr. Carr pleaded not guilty to the charge, Celtic Fire was found guilty and stewards directed that the greyhound perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1) (a), before any future nomination will be accepted.

Meeting Comments:

Satisfactory Trial Results - Spring Shangeye trialled over the 311m distance from box 4, weight 28.3kg, the greyhound was placed 4th in a field of 5 starters. The time of the trial was 18.12, the greyhound beaten by a margin of 11.5 lengths. Spring Shangeye was cleared.

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mr. R. Little, the trainer of Ninetymile Ace regarding the length of time since the greyhound last raced. Ninetymile Ace last raced on 22 September 2016 and is returning after a spell. Pursuant to GAR 77A, Ninetymile Ace trialled over the 311m distance

from box 8, weight 33.7kg, the greyhound was placed 5th in a field of 5 starters. The time of the trial was 18.12, the greyhound was beaten by a margin of 12 lengths. Ninetymile Ace was cleared.

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mr. S. Hughes, the trainer of Baby Blitzen regarding the length of time since the greyhound last raced. Baby Blitzen last raced on 13 September 2016 and is returning after a seasonal spell. Pursuant to GAR 77A, Baby Blitzen trialled over the 311m distance from box 1, weight 26.7kg, the greyhound was placed 3rd in a field of 5 starters. The time of the trial was 18.12, the greyhound was beaten by a margin of 8 lenthgs. Baby Blitzen was cleared.
