Mr. Wright stated that the greyhound was returning to race after an extended spell. Pursuant to GAR 77A, Ava Crowder trialled over the 390 metre distance from box 1, weight 25.5kgs. The greyhound was placed 4th, in a field of 4. The time of the trial was 22.39. The greyhound was beaten by a margin of 9.75 lengths. Ava Crowder was cleared.</p> <p>Stewards spoke to Ms. L. Desmond, the trainer of With A Whisper regarding the length of time since the greyhound last raced. With A Whisper last raced on 26th September 2016. Ms. Desmond stated that the greyhound was returning to race after injuries to both its back muscles.
