Meeting Comments:-

Trial One

Satisfactory Trial Results - Chrissy Pee trialled over the 390mts from box 5, weight 29.8kg, the greyhound was placed 3rd in a field of 4. The time of the trial was 22.49, the greyhound was beaten by a margin of 8.5L. Chrissy Pee was Cleared.

Satisfactory Trial Results - Proven Chat trialled over the 390mts from box 3, weight 30.0kg, the greyhound was placed 1st in a field of 4. The time of the trial was 22.49, the greyhound won by a margin of 8L. Proven Chat was Cleared.

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mr. A. Marum, the trainer of Whipstick Chloe regarding the length of time since the greyhound last raced. Whipstick Chloe last raced on 12th September 2016. Mr. Marum stated that the greyhound was returning from being spelled. Blue Sky Babe last raced on 7th August 2016. Ms. Jackson stated that the greyhound was new to the kennels. Pursuant to GAR 77A, Blue Sky Babe trialled over the 390mts from box 8, weight 26.7kg, the greyhound was placed 3rd in a field of 4. Satisfactory Trial Result - Kraken Suzie trialled over the 450mts from box 1, weight 26.1kg, the greyhound was placed 2nd in a field of 4. The time of the trial was 26.38, the greyhound was beaten by a margin of 1L. Kraken Suzie was Cleared.

Satisfactory Trial Result Weight - Kashmire Cashe trialled over the 450mts from box 8, weight 38.1kg, the greyhound was placed 4th in a field of 4. The time of the trial was 26.38, the greyhound was beaten by a margin of 1.75L. Kashmire Cashe was Cleared.
