I'm Mad was found guilty and suspended for 28 days at Ballarat and it was directed that the greyhound perform a Satisfactory Trial (all tracks), pursuant to GAR 69(2)(a) before any future nomination will be accepted.

Meeting Comments

Satisfactory Trial

Stewards spoke to Mr. K. Ward, the trainer of Wild Last Stress regarding the length of time the greyhound has had between races. Wild Last Stress last raced on 14th June 2015. Mr. Ward stated that the greyhound was returning to race after suffering a back muscle injury. Pursuant to GAR 77A, Wild Last Stress trialled over the 390 metre distance from box 1, weight 32.8kgs. The greyhound was placed 1st, in a field of 4. The time of the trial was 22.44. The greyhound won by a margin of 7.75 lengths. Wild Last Stress was cleared.
