It was reported that the greyhound sustained injuries to left hind leg muscle soreness ,a 5 day stand down period was imposed. Acting underGAR 69(B)(1), the stewards charged Jive Time with failing to pursue the lure with due commitment (by reason of injury). Mr J. Borg pleaded guilty to the charge, Jive Time was found guilty and stewards directed that the greyhound perform aSatisfactory Trial (all tracks)pursuant toGAR 69(B)(1) (a), before any future nomination will be accepted.
