Stewards spoke with track staff and after testing the gate, no further problems were reported. The three greyhounds involved were uninjured.

Stewards spoke with Mr P Pollutro, the trainer of Mandela Sun regarding interference caused in the home straight. Mr Pollutro stated that the greyhound's racing pattern is to head to the rail and in his opinion this was the cause of the interference. After reviewing the video replay, head on footage and based on Stewards own observations, it was concluded that the interference caused was a direct result of Mandela Sun crossing to the rail and on this occasion no further action was taken.
