suspended for 28 days at The Meadows (MEP) and it was directed that the greyhound perform a Satisfactory Trial (all tracks), pursuant to GAR 69(2)(a) before any future nomination will be accepted.

MEETING COMMENTS

Satisfactory Trial Results - Gravel Rash Riot trialled over the 525m from box 8, weight 30.8kg, the greyhound was placed first in a field of four starters. The time of the trial was 30.21, the greyhound won by a margin of 1.5L. Gravel Rash Riot was cleared.

Stewards interviewed Mr. L Medcraft regarding his leaving a greyhound unattended in his trailer which is in breach of part 20 of the Greyhound Racing Victoria Transportation of Greyhounds Policy. Stewards fined Mr. Medcraft the sum of \$200.
