Acting under GAR 69(B)(1), the stewards charged Shantui with failing to pursue the lure with due commitment (by reason of injury). Mr. Gavin pleaded not guilty to the charge, Shantui was found guilty and stewards directed that the greyhound perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1)(a), before any future nomination will be accepted.
