Satisfactory trial results:-

Summer Kate trialled over 315 metres from box 8, weight 29.0kg, the greyhound was placed fourth, in a field of 4. The time of the trial was 18.27 secs, the greyhound was tailed off. Summer Kate was not cleared. Summer Kate was vetted following the trial and found to have sustained an injured right semimembranous muscle, a 28 day stand down period was imposed.

Sultan's Pride trialled over 315 metres from box 1, weight 31.0kg, the greyhound was placed second, in a field of 4. The time of the trial was 18.27 secs, the greyhound was beaten by a margin of 14.25 lengths. Sultan's Pride was cleared.

Special Mate trialled over 315 metres from box 3, weight 30.5kg, the greyhound was placed third, in a field of 4. The time of the trial was 18.27 secs, the greyhound was beaten by a margin of 21 lenth. Special Mate was not cleared. Sultans Mate was vetted following the trial and no injury was apparent.
