Mat's Road was found guilty and stewards directed that the greyhound perform a satisfactory trial (all tracks) pursuant to GAR 69(B)(1)(a), before future nominations be accepted.

It was reported that the greyhound sustained injuries to the right monkey muscle, a 10 day stand down period was imposed. Tonk's Road was found guilty and stewards directed that the greyhound perform a satisfactory trial (all tracks) pursuant to GAR 69(B)(1)(a), before future nominations be accepted.
