Race 1

Sandtrack Sniper checked off He's A Freebie soon after the start. Sargent and He's A Freebie collided on the first turn, checking He's A Freebie and Sunset Queen. Poison Pen raced wide on the first turn through to the home straight. Sargent raced wide entering the home straight. She's Smoking and Sunset Queen collided approaching the winning post.

Poison Pen tired over the concluding stages of the event and was vetted. It was reported that the greyhound sustained an injury to the left tensor fascia (triangle) muscle. A five-day stand down period.

A sample was taken from Major Think, the winner of the event.

Race 3

TOP CAT VIDEO (300+RANK) 12:40 pm 460m Maiden There was a slight delay at the start of this race due to starter C. Barnes being required to remove excess water from a starting box.

My Girl Lois was quick to begin. Scarlet Evader was slow to begin.

Atigrado and She's A Beaut collided approaching the first turn. Scarlet Twice and My Girl Lois collided on the first turn. Atigrado and My Girl Lois collided in the home straight.

Atigrado was vetted following the event. It was reported that the greyhound sustained a carpal sprain of the left wrist. A seven-day stand down period was imposed.

A sample was taken from Dreamy Julian, the winner of the event.

Race 4

MEL'S KITCHEN (300+RANK)

1:00 pm 460m Maiden A pre-race sample was taken from Optima Semper.

Row Tay Tom, Optima Semper and Lady Talker were quick to begin. Night Attack was slow to begin.

Blulehawk Lady checked off Optima Semper soon after the start, checking Santana. Trademark Chops and Lady Talker collided on the first turn, checking Trademark Chops. Rodeo and Santana raced wide in the home straight.

Race 5

TOP RUN IMAGES (300+RANK)

1:15 pm 460m Grade 6 Popowski, Miata Gold, Happy Hamish and Zulu Zoe collided soon after the start, checking Miata Gold and Happy Hamish. Taabinga Swift stumbled on the first turn and lost ground.

Gats Prodigy was vetted after the event following an incident in the catching pen. It was reported that the greyhound sustained a tarsal fracture to the right hock. A 28-day stand down period was imposed.

Stewards directed that Mr John Connor present the greyhound Taabinga Swift to the Sale meeting on 28/04/17 for a veterinary examination after he left the course without Stewards permission.

Race 6

FIND US ON FACEBOOK (300+RANK) 1:39 pm 460m Grade 5 Stewards spoke to Mr Gino Bisognin, the representative of Lisburn Gem, regarding the length of time the greyhound has had between races. Lisburn Gem last raced on 18 January 2017 and is returning after a front left toe injury.

A pre-race sample was taken from Veetee Mist.

Lisburn Gem, Aztec Flash and Snow Matter were slow to begin. Veetee Mist checked off Turfman on the first turn.

Sunset Senorita tired over the concluding stages of the event and was vetted. It was reported that the greyhound sustained no apparent injury. Stewards spoke to Mr Ryan Bean, the trainer of Sunset Senorita, regarding the greyhound's performance over the concluding stages. Mr Bean stated that he believed the greyhound had tired as it had stepped up in distance for this event and has only had one trial over a similar distance in the past. Stewards noted Mr Bean's explanation and took no further action.

A sample was taken from Turfman, the winner of the event.

Race 7

WWR SAWDUST (300+RANK) 1:54 pm 400m Grade 5 Rusty Mia and Kiyoshi were quick to begin. Diamond Maxine was slow to begin. No Road and Rusty Mia collided approaching the first turn, checking No Road. Angry Alley, Miz Josie and Diamond Maxine collided on the first turn, checking Miz Josie. Rock Me Baby, Buckle Up Todd and Angry Alley collided on the first turn, checking Angry Alley and severely checking Rock Me Baby which tailed off; Buckle Up Todd fell as a result. Diamond Maxine checked off Kiyoshi approaching the home turn. Diamond Maxine raced wide entering the home straight.

Buckle Up Todd was vetted following the event. It was reported that the greyhound sustained an injury to the right gracillis (back) muscle. A five-day stand down period was imposed.

Rock Me Baby was vetted following the event. It was reported that the greyhound sustained a laceration to the right hind and an abrasion to the left calf. Aten-day stand down period was imposed.

Race 8

ENDEAVOR LOCKSMITHS (300+RANK) 2:14 pm 460m Grade 5 A pre-race sample, upon arrival at the course, prior to kennelling was unable to be obtained from Kayo King. A subsequent pre-race sample was taken.

Elite Shiraz and Jupiter Jones were quick to begin.

Freedom Fire was slow to begin.

Kayo King checked off Jupiter Jones on the first turn. Never Satisfied checked off Amaroo Gonzales on the first turn. Elite Shiraz checked off Blue Squirrel in the home straight. Elite Shiraz eased approaching the winning post.

Celtic Charm was vetted following the event. It was reported that the greyhound sustained injuries to the right tensor fascia (triangle) muscle and right hind toe. A ten-day stand down period was imposed.

Stewards spoke to Mr Trevor Whitford, the trainer of the greyhound Elite Shiraz, regarding the greyhound's racing manners approaching the winning post. Elite Shiraz was vetted, and revetted following event 11, and found to have no apparent injury. Acting under GAR 69(A)(1) stewards charged Elite Shiraz with failing to pursue the lure with due commitment. Mr Whitford pleaded guilty to the charge, Elite Shiraz was found guilty and suspended for 28 days at Warragul and it was directed that the greyhound perform a Satisfactory Trial (all tracks), pursuant to GAR 69(A)(2)(a) before any future nomination will be accepted.

Race 9

BLUE STREAM PICTURES (300+RANK) 2:42 pm 460m Grade 7 A pre-race sample was taken from Form A Circle and from Gaz's Rooster.

Aladdin Prince, Form A Circle and Spyfection were quick to begin.

Diesel Turbo was slow to begin.

Starlit Dragon and Aladdin Prince collided approaching the first turn, causing Aladdin Prince to brush the running rail.

Smokey Senor checked off Two Toes Tony entering the home straight. Why Not Lyn checked off Two Toes Tony in the home straight. Aminya Shadow and Pie Problem collided approaching the winning post.

Master McEvoy checked off Freemason on the first turn. Master McEvoy and Miss Who collided entering the home straight. Dane Daisy and Freemason collided in the home straight. Miss Who, Dane Daisy and Titanium Boy collided several times in the home straight.

A sample was taken from Freemason, the winner of the event.

TAB REWARDS (300+RANK) 3:44 pm 400m Grade 6 A pre-race sample was taken from Kayla Las and from Thor's Crest.

Kayla Las and Elram Girl were quick to begin.

Memphis Victorem and Dr. Dunstan were slow to begin.

It's Debatable and Memphis Victorem collided approaching the first turn. Dr. Shanice checked off Thor's Crest approaching the home turn. Memphis Victorem lost ground approaching the home turn. It's Debatable raced wide in the home straight.

Memphis Victorem was vetted and revetted following event twelve. It was reported that the greyhound sustained no apparent injury.

Stewards spoke to Mr D Jeffries, the handler of the greyhound Memphis Victorem. Stewards deemed the performance of Memphis Victorem unsatisfactory in this event and acting in accordance with GAR 71, directed that Memphis Victorem must perform a Satisfactory Trial (all tracks) before any future nomination will be accepted.

MEETING COMMENTS

Satisfactory Trial Results - My Mate Horse trialled over the 460m from box one, weight 33.1kg, the greyhound was placed third in a field of four. The time of the trial was 26.17, the greyhound was beaten by a margin of 2L. My Mate Horse was cleared.

Satisfactory Trial Results - Shreddin' trialled over the 460m from box eight, weight 35.9kg, the greyhound was placed second in a field of four. The time of the trial was 26.17, the greyhound was beaten by a margin of 0.75L. Shreddin' was not cleared.
