Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mr S Gibilisco, the trainer of Bobby Tron, regarding the length of time since the greyhound last raced. Bobby Tron last raced on 12 October 2016. Mr Gibilisco stated that the greyhound was returning to racing after a right hind foot injury. Pursuant to GAR 77A, Bobby Tron trialled over the 425m from box two, weight 33.6kgs, the greyhound was placed third in a field of four starters. The time of the trial was 24:15, the greyhound was beaten by a margin of 9.75 lengths. Bobby Tron was Cleared.

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mr K Hunt, the trainer of Natari, regarding the length of time since the greyhound last raced. Natari last raced on 20 April 2016.
