Mr. Ward pleaded guilty to the charge, Jack's Rainbow was found guilty and suspended for 28 days at Bendigo and it was directed that the greyhound perform a Satisfactory Trial (all tracks), pursuant to GAR 69(2)(a) before any future nomination will be accepted.

Stewards spoke to Mr. T. Collins the handler, regarding the direction that the greyhound Ryhan's Request be boxed first. Acting under GAR 52(2) Stewards directed that this box first be removed.

Meeting Comments:-

Satisfactory Trial Results - Perfect Lily trialled over the 425mt from box 8, weight 28.2kg, the greyhound was placed 4th in a field of 4. The time of the trial was 24.12, the greyhound was beaten by a margin of 8.50L. Perfect Lily was Cleared.

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mr. B. Bravo, the trainer of What's Chewing regarding the length of time since the greyhound last raced. What's Chewing last raced on 2/11/2015. Mr. Bravo stated that the greyhound was returning from a broken right tarsal. Pursuant to GAR 77A, What's Chewing trialled over the 425mt from box 1, weight 35.6kg, the greyhound was placed 1st in a field of 4. The time of the trial was 24.12, the greyhound won by a margin of 2.75L. What's Chewing was Cleared.
