Meeting Comments:

Trial 1

Satisfactory Trial Results - Relethor Bale trialled over the 400m from box1, weight 31.2kg, the greyhound was placed 3rd in a field of 4. The time of the trial was 22.82, the greyhound was beaten by a margin of 4L. Relethor Bale was Cleared.

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mrs. H Collins, the trainer of Allen Jabez regarding the length of time since the greyhound last raced. Allen Jabez last raced on 28th October, 2016

and is returning to racing after a change of kennel. Pursuant to GAR 77A, Allen Jabez trialled over the 400m from box 3, weight 31.7kg, the greyhound was placed 1st in a field of 4. The time of the trial was 22.82, the greyhound won by a margin of 0.75L. Allen Jabez was Cleared.

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mr. F Bahor, the trainer of All Black regarding the length of time since the greyhound last raced. All Black last raced on 14th July, 2016 and is returning to racing after a season and a hock injury. Pursuant to GAR 77A, All Black trialled over the 400m from box 5, weight 25.4kg, the greyhound was placed 4th in a field of 4. The time of the trial was 22.82, the greyhound was beaten a margin of 11L. All Black was Cleared.

Trial 2

Satisfactory Trial Results - Dyna Gary trialled over the 460m from box 1, weight 30.5kg, the greyhound was placed 3rd in a field of 4. The time of the trial was 26.01, the greyhound was beaten by a margin of 6.5L. Dyna Gary was Cleared.

Satisfactory Trial Results - Queen Quick trialled over the 460m from box 3, weight 28.8kg, the greyhound was placed 1st in a field of 4. The time of the trial was 26.01, the greyhoundwon by a margin of 2.75L. Queen Quick was Cleared.
