Mr. Buckingham stated that the greyhound was returning to racing following a back injury and extended spell . Pursuant to GAR 77A, Cosmic Bay trialled over the 390m from box 1, weight 28.9kg, the greyhound was placed first in a field of four starters. The time of the trial was 22.44, the greyhound won by a margin of 4L. Cosmic Bay was cleared.

Satisfactory Weight Trial (Solo) - Kentucky Sun trialled over the 390m from box 1, weight 33.1kg. The time of the trial was 22.64, Kentucky Sun was cleared.
