Acting under GAR 69(A)(1), Stewards charged Bush Dancer with failing to pursue the lure with due commitment. Mr. Rennie pleaded guilty to the charge. Bush Dancer was found guilty and suspended for 28 days at Warrnambool and it was directed that the greyhound perform a Satisfactory Trial (all tracks), pursuant to GAR 69(A)(2)(a), before any future nomination will be accepted.</p> <p>Stewards spoke to Mr. J. Rennie, the handler of the greyhound Bush Dancer regarding his failure to appear at the kennels by the appointed time to retrieve the greyhound for racing. Stewards charged Mr. Rennie with a breach of GAR 46(2). Mr. Rennie pleaded guilty to the charge. Mr. Rennie was found guilty and fined the sum of \$100.</p> <p>A sample was taken from Toon Town, the winner of the event.</p>
