Mr Lesjak pleaded not guilty to the charge, Shrek's Fairy was found guilty and suspended for 28 days at Warragul and it was directed that the greyhound perform a Satisfactory Trial (all tracks), pursuant to GAR 69(2)(a) before any future nomination will be accepted.
