Mr. Robertson pleaded guilty to the charge, Brianna Morgan was found guilty and stewards directed that the greyhound perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1)(a), before any future nomination will be accepted.

Grand Cayman was vetted following the event. It was reported that the greyhound sustained soreness to both deltoid muscles and the right neck muscle, a seven day stand down period was imposed.

Acting under GAR 69(A)(1) stewards charged My Lady Limonite with failing to pursue the lure with due commitment. Mr. Eades pleaded not guilty to the charge, My Lady Limonite was found guilty and suspended for 28 days at Sandown and it was directed that the greyhound perform a Satisfactory Trial (all tracks), pursuant to GAR 69(A)(2)(a) before any future nomination will be accepted.
