Acting under GAR 69(B)(1) Stewards charged Reignlee with failing to pursue the lure with due commitment by reason of injury. Mr. Formosa pleaded guilty to the charge, Reignlee was found guilty and Stewards directed that the greyhound perform a satisfactory trial all tracks pursuant to GAR 69(B)(1)(a) before any future nomination will be accepted.
