Mr Hanke refused and prevented the taking of this sample and disobeyed the order of steward Mr Scott Gillespie. Stewards allowed Mr Hanke to kennel the greyhound whilst an inquiry was conducted into the circumstances. Stewards heard evidence from GRV Stewards Mr C Day and Mr S. Gillespie, and trainer Mr M Hanke. After considering the evidence Stewards ordered the withdrawal of Bound After Gold who was a late scratching at 11:47am by order of stewards; pursuant to GAR20(4). A sample was subsequently taken from Bound After Gold at 11:57am. Stewards adjourned the inquiry to a date to be fixed.

Destini Seajewel and Lektra Stomp were quick to begin. Alberto checked off the heels of Destini Seajewel soon after the start. Destini Seajewel and Black Market collided on the first turn.
