McKenzie the representative of Amelia Star regarding the length of time since the greyhound last raced. Amelia Star last raced on 09/06/16. Mr. McKenzie stated that the greyhound was returning to racing following a right calf injury and a seasonal spell. Pursuant to GAR 77A Amelia Star trialled over 315 metres from box 1, weight 27.9kg, the greyhound was placed fourth in a field of 4. The time of the trial was 18.44 secs, the gryehound was beaten by a margin of 8.25 lengths.
