Satisfactory Trial Results - Cette To Dance trialled over the 450m from box 2, weight 27.7kg, the greyhound was placed 4th in a field of five. The time of the trial was 25.98, the greyhound was beaten by a margin of 4.5L. Cette To Dance was Cleared.

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mr. P. Santoro, the trainer of Lee I Am regarding the length of time since the greyhound last raced. Lee I Am last raced on 14th September 2016. Mr. Santoro stated that Lee I Am was returning to race after suffering a right stopper bone injury.
