Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mr Brett McIntyre, the trainer of Doyen Ruler, regarding the length of time since the greyhound last raced. Doyen Ruler last raced on the 28 December 2016. Mr McIntyre stated that the greyhound had been recovering from split webbing. Pursuant to GAR 77A, Doyen Ruler trialled over the 400m from box one, weight 34.7kg, the greyhound was placed first in a field of four. The time of the trial was 23.04, the greyhound won by a margin of 1L. Doyen Ruler was cleared.

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mr David Schwarz, the trainer of Duke Of Dallas, regarding the length of time since the greyhound last raced. Duke Of Dallas last raced on the 23 December 2016. Mr Schwarz stated that the greyhound had been recovering from split webbing.
