Track Curator Mr M.Pell advised stewards that the track was lightly harrowed on 25th June, 2017.

Satisfactory Trial Results - Inga Ted trialled over the 425m from box 1, weight 33.4kg, the greyhound was placed 2nd in a field of 4 starters. The time of the trial was 24.61, the greyhound was beaten by a margin of 1.5L. Inga Ted was cleared.

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mrs. P. Patterson, the trainer of Quicksilver Hope regarding the length of time since the greyhound last raced. Quicksilver Hope last raced on 28th November 2016. Mrs. Patterson stated that the greyhound was returning from a spell and being on season. Pursuant to GAR 77A, Quicksilver Hope trialled over the 425mts from box 5, weight 24.4kg, the greyhound was placed 3rd in a field of 4. The time of the trial was 24.61, the greyhound was beaten by a margin of 1.75L. Quicksilver Hope was cleared.
