Satisfactory Trial Results

Shall She Cindy trialled over the 311 metre distance from box 1, weight 27.9kgs. The greyhound was placed 1st, in a field of 4. The time of the trial was 18.39. The greyhound won by a margin of 0.5 lengths. Shall She Cindy was cleared.

Stewards spoke to Mrs. P. Burns, the trainer of Buckle Up Spitz regarding the length of time since the greyhound last raced. Buckle Up Spitz last raced on 8th September 2016. Mrs. Burns stated that the greyhound was returning to race from a right back muscle and left triangle muscle injuries. Pursuant to GAR 77A, Buckle Up Spitz trialled over the 311 metre distance from box 3, weight 33.7kgs. The greyhound was placed 3rd, in a field of 4. The time of the trial was 18.39. The greyhound was beaten by a margin of 1 length. Buckle Up Spitz was cleared.

She's Smoking trialled over the 311 metre distance from box 5, weight 24.7kgs. The greyhound was placed 4th, in a field of 4. The time of the trial was 18.39. The greyhound was beaten by a margin of 10.25 lengths. She's Smoking was cleared.
