### Satisfactory Trial Results

Stewards spoke to Mr. G. Turnbull, the trainer of Jacana regarding the length of time since the greyhound last raced. Jacana last raced on 27th August 2015. Mr. Turnbull stated that the greyhound was returning to race after being on season. Pursuant to GAR 77A, Jacana trialled over the 390 metre distance from box 2, weight 25.8kgs. The greyhound was placed 1st, in a field of 4. The time of the trial was 22.80. The greyhound won by a margin of 2.75 lengths. Jacana was cleared.

Stewards spoke to Mr. G. Turnbull, the trainer of Rayvon regarding the length of time since the greyhound last raced. Rayvon last raced on 27th May 2015. Mr. Turnbull stated that the greyhound was returning to race after a spell. Pursuant to GAR 77A, Rayvon trialled over the 390 metre distance from box 4, weight 31.9kgs. The greyhound was placed 2nd, in a field of 4. The time of the trial was 22.80. The greyhound was beaten by a margin of 2.75 lengths. Rayvon was cleared.
