Paterson, the trainer of Albert's Patch regarding the length of time since the greyhound last raced. Albert's Patch last raced on 12th October 2015. Mr. Paterson stated that the greyhound was returning to race after being on season and a new kennel. Pursuant to GAR 77A, Albert's Patch trialled over the 400 metre distance from box 1, weight 27.8kgs. The greyhound was placed 4th, in a field of 4. The time of the trial was 23.14. The greyhound was beaten by a margin of 11.5 lengths. Albert's Patch was cleared.</p> <p>It's A Buzz trialled over the 400 metre distance from box 6, weight 31.8kgs. The greyhound was placed 2nd, in a field of 4. The time of the trial was 23.14. The greyhound was beaten by a margin of 7.75 lengths.
