Mr Mowat stated that the greyhound was new to the kennel and was returning to racing after recovering from injury. A new weight of 30.8kg was also declared for the greyhound in accordance with GAR 39(2). One For One last raced at 28.9kg. Seabrook Gem and Superior Bobby were slow to begin. One For One and Rose Magic collided soon after the start, checking One For One and Steely Sprite. Jack Of Meade, Steely Sprite, One For One and Seabrook Gem collided approaching the 250m mark. Superior Bobby checked off Jack Of Meade at the 150m mark. One For One checked off Seabrook Gem at the 100m mark. Superior Bobby and Jack Of Meade at the 50m mark.
