Satisfactory Trial Results GAR (77A) - Stewards spoke to Mrs. Pirani, the trainer of Gardsman regarding the length of time since the greyhound last raced. Gardsman last raced on 30th November 2016. Mrs. Pirani stated that the greyhound was returning to racing following an injured back muscle. Gardsman trialled over the 400m from box 1, weight 31.8kgs, the greyhound was placed 1st in a field of 5. The time of the trial was 22.92, the greyhound won by a margin of 6.75 lengths. Gardsman was Cleared.

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mr. M. Johnson the trainer of Kimmy Bale regarding the length of time since the greyhound last raced. Kimmy Bale last raced on 14th September, 2016. Mr. Johnson stated that the greyhound was returning to racing following a change of kennels and a spell. Kimmy Bale trialled over the 400m from box 2, weight 30.0kgs, the greyhound was placed 2nd in a field of 5. The time of the trial was 22.92, the greyhound was beaten by a margin of 6.75 lengths.
