MEETING COMMENTS:

Satisfactory Trial Results - Black Odessa trialled over the 315m from box 1, weight 29.1kgs, the greyhound was placed 3rd in a field of 4. The time of the trial was 18.31, the greyhound was beaten by a margin of 1.0 lenth. Black Odessa was Cleared.

Satisfactory Trial Results (Blinkers) - Hurricane Lucas trialled over the 315m from box 3, weight 32.2kgs, the greyhound was placed 4th in a field of 4. The time of the trial was 18.31, the greyhound was beaten by a margin of 12.50 lengths. Hurricane Lucas was Cleared.

Satisfactory Trial Results - Ultimate Connor trialled over the 315m from box 6, weight 31.0kgs, the greyhound was placed 1st in a field of 4. The time of the trial was 18.31, the greyhound won by a margin of .25 lengths. Ultimate Connor was Cleared.
