Acting under GAR 69(B)(1), the stewards charged Watch Me Wyn with failing to pursue the lure with due commitment (by reason of injury). Mr Welsh pleaded guilty to the charge, Watch Me Wyn was found guilty and stewards directed that the greyhound perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1)(a), before any future nomination will be accepted.

Meeting Comments

Satisfactory Trial Results - Mystic Powers trialled over the 390m from box 8, weight 33.8kg, the greyhound was placed 3rd in a field of 4. The time of the trial was 22.74, the greyhound was beaten by a margin of 2.25L. Mystic Powers was Cleared.

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mr C Rose, the trainer of Ima Cosmic regarding the length of time since the greyhound last raced. Ima Cosmic last raced on 17/8/2016. Mr Rose stated that the greyhound was returning to race following surgery on the ligaments of it's right front foot. Pursuant to GAR 77A, Ima Cosmic trialled over the 390m from box 2, weight 28.8kg, the greyhound was placed 1st in a field of 4. The time of the trial was 22.74, the greyhound won by a margin of 2L. Ima Cosmic was Cleared.
