Blues with failing to pursue the lure with due commitment. Mr Pursell pleaded guilty to the charge, Jazz Me Blues was found guilty and stewards directed that the greyhound perform a Satisfactory Trial (all tracks), pursuant to GAR 69(B)(1)(a) before any future nomination will be accepted.
