Porscha's Girl and Royal Welsh collided at the 200m mark and again at the 150m mark. Super Serena and Latissimus Dorsi collided at the 100m mark. After taking evidence from both Ms Cornell and Mr Barker, Stewards charged Ms Cornell pursuant to GAR 86(o) for negligently failing to catch the greyhound at the conclusion of the event. Ms. Cornell pleaded guilty to the charge and was suspended for one month, effective midnight 26 November 2017. Stewards, in determining their decision, took into account the previous history of Ms Cornell's failure to catch greyhounds on a number of occasions.</p>
